#### 1.Welcome

Mr. Michael Yang, Secretary General of CATIA and current Chairman of GTF, opened the afternoon meeting by welcoming the group of international delegates. And warmly thanked all the participants' support and help, especially from Afera, PSTC, JAMTA and TAAT.

# 2. Review and accept minutes from the Brussels meeting 2023

Mr. Michael Yang reviewed the minutes from the Brussels meeting last year and reviewed the agenda points and conclusions of the pre-meeting.

# 3. Review the Objectives of the GTF as published on the website

Mr. Michael Yang reviewed the objectives of the GTF as published on the website:

- Harmonize key adhesive tape test methods.
- Establish a database of environmental and regulatory trends by region.
- Gather top-level production data according to agreed categories.
- Share an open calendar of global adhesive tape educational events. Everyone should benefit from participating in each other's regional events.
- Hold biennial meetings hosted by member associations on a rotating basis.
- Establish a small shared fund for running costs.
- Appoint a fixed team of volunteer delegates, plus a secretariat from each member association to serve a 3-year term.

# 4. Review Action items from the Brussels meeting 2023

Dr. Evert Smit and Mr. Michel Merkx talked about the database issues of relevant documents on the GTF website. They suggested that people could be able to download the relevant documents from the GTF official website.

## 5.Membership: Review potential for more members

Mr. Michael Yang asked about the possibility of increasing the members of GTF.

Mr. Michel Merkx suggested that India and South America might be relevant options but was not sure about the status of such Associations in these regions. He also stated that, as a point of principle, the GTF should remain open for potential new member associations.

Dr. Evert Smit agreed with Mr. Michel Merkx that India should be considered, and he mentioned that he is in contact with an adhesive association named ICATA in India but awaits a status update.

Mr. Michael Yang also agreed that GTF should keep open, and he also mentioned that ICATA was more focused on adhesives rather than tapes.

#### 6.Organizational structure

Mr. Michael Yang and Mr. Kiran Malhotra nominated Mr. Kensei Takahashi, the Secretary General of JAMTA as the Chairman for the following 2-year term. And Mr. Kensei Takahashi was accepted by all GTF members.

# 7.Budget

# Treasurer's report

Ms. Alice Chang, Secretary General of TAAT, made the financial report for GTF from the period of 2011 to 2023, and the net income until this meeting was 8,916.48 US Dollars.

# Decision on additional funding

Afera is administering the GTF web page. Dr. Evert Smit explained the increases in the Web/domain costs in 2023 and 2024 due to the SLA cyber security and maintenance.

Mr. Michel Merkx offered the consideration to increase the funding for the GTF account.

# **ACTION:**

- After review and discussion all members agreed that each GTF member will deposit \$3,000 US Dollars by the end of June, 2024.
- Ms. Alice Chang to provide bank account details of GTF to all the GTF members after the meeting.

#### 8.Demand increase initiatives

Presentation of tape market and trends in each country and region by each association/Presentation of the regulations for Environmental, Health and Safety in each country and region by each association

#### Afera——

Dr. Evert Smit first presented the details about the Afera such as the composition of members, global counterpart organizations and teaming up with associations. Then he elaborated on the market of PSA, tape and specialty tape in Europe and world. He also pointed out that the greatest threats in tape businesses are regulations and foremost trends affecting tape business is working towards a circular economy. He presented the European regulations for the environmental, health and safety. He explained the concepts underlying the European Green Deal: 2019-2024, regulatory affairs, Packaging and Packaging Waste Regulation (PPWR) and regulatory requirements in detail. At the end, he showed us the Afera/IVK PCF calculation tool timeline.

#### JAMTA---

Mr. Kensei Takahashi presented JATMA aimed at overall improvement in the growth of Japanese adhesive tape industry and contributing to public benefit with 14 members and 81 supporting members in the association. JAMTA divided the adhesive tape market into 5 different categories, Paper, Cloth, Film, Specialty tapes and Sheet.

Mr. Kensei Takahashi presented the market sales and volume in Japan for each category and explained the diffusion index related to the infection wave, especially the situation in 2021. On the subject of environmental, health and safety issues he presented data on the VOC used and emission amounts by adhesive tape production of member companies that are reported to the Japanese government. VOC reduction, challenges to free VOC were further elaborated. He stated that the Japanese PSA tape market volume was shrinking slowly, Covid issue impacted not only the volume of adhesive tape market, but also resulted in higher prices. Tape manufacturers promoted high value-added production with sustainable management.

#### TAAT---

Dr. Chi-Yue Wu, Technical Consultant of Four Pillars Enterprise Co., Ltd., from TAAT presented an overview of the association. And Dr. Wu elaborated the Sustainable Development Goals (SDGs) and 2050 Net-zero Transition for the regulations and environmental parts in Taiwan.

#### PSTC——

Mr. Michel Merkx presented details about the PSTC organization and the committees. There are six active committees (Education, Marketing, Technical, Member Services, EH&S and the Global Tape Forum) functioning currently. He stated that the North American tape market is expected to grow at a CAGR of 5.1% in the period 2022 to 2028 and the specialty tape market is expected to grow at 5.6% CAGR in the same period. He presented PSTC's market research for 7 sectors (Aerospace, Marine, Railway/Automotive/Appliances/ Construction and Building/Electronics/Medical/Other Manufacturing, Fabrication, or Component Assembly). The purpose of the market research was to understand the decision drivers that were influencing current specification and usage of different bonding solutions, assessing the key barriers to converting usage of other bonding solutions to PSA tape, and identifying the industries and applications that were most likely to convert.

## CATIA——

Mr. Michael Yang presented the market and trends of tapes in China by comparison of national GDP growth rate and China's tape industry production growth rate, changes in tape industry segments in China, production, and growth rate of various types of adhesive tape in China and import and export situation of tape in China from 2019 to 2023. He also summarized China's tape industry for 2023 into six development features. At the end, he believed that the market opportunities and trend of tape industry would be in transportation, medical products, consumer electronics, and industrial manufacturing fields and UV hot melt pressure-sensitive adhesive, bio-based and biodegradable adhesive tape products, he concluded that China adhesive tape industry would enter a transformation stage of "low-speed and high-quality development".

Mr. Hu Yang made the presentation on the topic of regulations for environment and safety in Mainland China. First, he talked about Industrial policy updates for the past 4 years, and then presented legal requirements for plastic pollution treatment of *Opinions on Further Strengthening the Treatment of Plastic Pollution* and "Fourteenth Five-Year Plan" Action Plan for Plastic Pollution Control. Finally, he summarized 7 standards were implemented in 2023, one was national standard and 6 were industry standards.

# Discussion on global initiatives of promoting demand increase

Mr. Michel Merkx suggested giving more thought about possible global initiatives but perhaps we could expand on a working (best practice) initiative of one of the GTF organizations.

# 9. Discussion on the harmonized classification terminology

Mr. Michael Yang mentioned the examples of the **Adhesive Industry**, in 2012, all the Adhesive Associations harmonized classification terminology for adhesive industry, and the harmonized manual was updated in 2022.

Dr. Evert Smit said that in the tape industries, the classification was more complicated than that of adhesive industries and giving more explanation and definition of different tapes might make the task easier.

Mr. Michel Merkx agreed with Dr. Smit and elaborated on that point.

Mr. Kensei Takahashi said that it was difficult to realize the application of different types of tapes.

Ms. Alice Chang said that she agreed the classification from all the perspectives, no matter from the substrates of materials or applications.

Mr. Kiran Malhotra said that we should know the purpose of making the classification, rather than just classifying arbitrarily.

#### 10.GTF Awareness

Mr. Michael Yang made the discussion on the possibility of launching an International "Adhesive Tape Day", he mentioned that 9.29 (September 29) was the international day of adhesive, should we propose a day of International Adhesive Tape Day?

Dr. Evert Smit said that we should do it from the perspective of our customers, and we should advertise our products into the areas that need to do the advertising.

Mr. Michel Merkx believed that International "Adhesive Tape Day" was a good tool for promoting tapes.

Mr. Kensei Takahashi commented on the details of an International "Adhesive Tape Day", we should hold seminars or activities or giving gifts on this day.

Ms. Alice Chang agreed with the proposal of launching an International "Adhesive Tape Day".

Mr. Michael Yang concluded that more information should be discussed in the next

GTF meeting.

# 11.Discussion on beyond 2024 venue and term

Mr. Kensei Takahashi stated that the next meeting will take place from November 17 to 19, 2026, at Hamamatsucho Convention Hall, Tokyo. And that the Tokyo Metropolitan government would provide *Financial Support, In-Kind Support* and *Event Marketing Support*. He welcomed all the people to take part in the next meeting.

## 12.Conclusion

All the GTF members agreed that Mr. Kensei Takahashi will be the GTF Chairman for the following 2-year term.

Mr. Michael Yang thanked all the participants for their kind supports and participation.
